We are very excited to provide this opportunity for your students to work with internationally renowned composer and Lyricist who is specializing in music for the stage and screen, choral work, and pop songwriting Jennifer Lucy Cook.

High school students from across the state (and beyond) will join us for a day of workshops and music-making with Jennifer Lucy Cook, Dr. Matthew Brady, Frost Chorale and the students of the Frost Choral Studies Program.

Who is Jennifer Lucy Cook?

Jennifer Lucy Cook (she/her) is a composer and lyricist based in Los Angeles who specializes in contemporary classical vocal and choral music and music for the stage and screen. She is the recipient of the Chorus Austin Composition Prize, the Cantus Emerging Composer Award, the HerVoice Female Composer Prize, and the Edwin Fissinger Composition Prize. Recent choral commissions include Phoenix Chorale, Vox Femina Los Angeles, and the San Francisco Gay Men's Chorus, and she made her Carnegie Hall debut

this Spring. Her piece entitled "Time" is in the top ten bestselling concert choral works overall for J.W. Pepper in 2024, and was awarded a Director's Choice. Both "Time" and her arrangement of Billie Eilish's "What Was I Made For" received a J.W. Pepper Editor's Choice for 2024.

She is currently working with Oscar-winning composer Alan Menken on his A Whole New World for Alan Menken solo show, with performances at the London Palladium and in Osaka, Japan. She is an alumnus of the Johnny Mercer Foundation Writer's Grove with Goodspeed Musicals and the Edinburgh Fringe Festival. Other theater commissions include Full House Theatre Co., British Youth Musical Theatre, and Shakespeare's Globe Theatre in London. Her musical recaps of the Bachelor and excerpts from the musical Salem went viral on TikTok, where Jen enjoys connecting with the broader music community. She earned her Master of Arts in Musical Theater Writing from Goldsmiths University in London and her Bachelor of Music in Media Music from Brigham Young University.

Who is the Frost Chorale?

The premier choral ensemble at the Frost School of Music, the Frost Chorale performs the entire canon of choral music, gives world premieres, makes acclaimed recordings, and travels both nationally and abroad. The Chorale has appeared at regional and national conventions and regularly joins professional orchestras to perform the great choral-orchestral repertoire.

Who can participate in the honor choir?

This is an opportunity for you to honor your highest achieving students to come make music with world-renowned composers and clinicians. There is no audition; instead, high school choral directors can register up to two quartets (total eight students, balanced number of sopranos, altos, tenors, and basses) to participate. We are looking for those truly dedicated students of a high musical caliber who will relish a once-in-a-lifetime opportunity such as this. How should I select my students?

You may use any method you wish. If you have students in mind you know would rise to the challenge and excel at this opportunity, you can pick them with no audition. If you would like to audition your students, that is fine as well. We only need to know who you are sending.

Music

Once payment is received, students (and teachers) will receive a digital copy of the music they are to learn. They should print their own music to bring with them in a black folder or binder. Students need to be able to confidently sing their voice part when they arrive at the honor choir so that we do not need to review notes and rhythms. To aid in the learning process, we will provide practice tracks for all pieces.

ATTENDING THE HONOR CHOIR

Teachers and Chaperones

Each school/organization must have at least one chaperone registered and in attendance at all times throughout the honor choir. Chaperones must have a level two background check in order to represent their school/organization and attend the Honor Choir event. Many schools require registered chaperones to have this background check already; if you are unsure, check with your administration. We do NOT need documentation that this has been completed. The chaperone may be the teacher/director. Please follow your organization's/school's, and county's guidelines for chaperones. Chaperones are responsible for our guest students and must be with them at all times during the Honor Choir. Teachers/directors are not required to attend, but are highly encouraged. This will be a wonderful opportunity to watch Jennifer Lucy Cook and Dr. Matthew Brady work with your students, and we will sign any paperwork needed to count this as professional development. If a teacher attends, they must also register.

Transportation (registration and more detail will be provided)

Students/chaperones/directors will need to provide their own transportation to and from the honor choir. You have the option to purchase a parking pass from the University for \$13 to park on campus. (Buses do NOT need parking passes.) Once registration and payment is complete, you will be emailed a link to purchase a parking pass and enter your vehicle information. Please do so by **Wednesday**, **October 15**.

Parking passes are registered digitally through the University; therefore, you will not receive a physical pass. (The parking pass is for Friday only; if parking on other days, please follow visitor parking guidelines found here.) Visitor parking will be in Pavia and Levante Garages (see parking map attached to this document). You may also use paid street parking along San Amaro Drive if you do not wish to purchase a pass. If you wish to fly and rent a car, the closest airport is Miami International Airport (MIA).

Schedule

Registration begins at 8am in the Gusman Concert Hall lobby. The honor choir begins at 9am with lunch and dinner breaks (on your own) and concludes with the combined Frost Chorale and Honor Choir concert at 7:30pm. It is important all participants stay and perform in the evening concert. Only honor choir participants, chaperones, and teachers

are allowed in the honor choir rehearsals during the day, but all friends and family are invited to attend the concert at 7:30pm.

<u>Friday Concert</u>: This year, we are very excited to offer a formal honor choir performance on the Gusman stage. <u>All</u> Honor Choir participants will perform with the Frost Chorale, Dr. Matthew Brady, and Jennifer Lucy Cook on Friday, October 24th at 7:30pm in Gusman Concert Hall as part of the Frost Concert Series.

They should wear their <u>honor choir t-shirt and solid black bottoms</u>. All Honor Choir participants and chaperones, once registered, will receive a code for one free ticket to the concert (honor choir participants will sit in the audience and <u>do not need a ticket</u>). Once you receive the code, sign up for tickets quickly, as these spots are limited.

Ticket information is <u>here</u>. The performance will also be live-streamed through the Frost Music Live website <u>here</u>.

Lunch

Lunch will be on your own on the University of Miami campus. There are several restaurant options within walking distance. <u>All students must be with their chaperone during lunch.</u>

Dinner

Dinner will be on your own in Coral Gables around the campus. (Most campus food locations are closed at this time.) There are numerous restaurant options within driving distance. All students must be with their chaperone/parent/guardian/teacher during dinner. It is important all students are picked up at 4:30pm outside Gusman Concert Hall and return by 6:30pm. No students may stay in Gusman, as there will be other rehearsals.

Expectations

It is the expectation that all students will be on their best behavior throughout the honor choir. You are representatives of your school and guests of the University of Miami. Please make sure you are familiar with and follow your own school/organization's code of conduct. In addition, please read the University of Miami's Youth Protection Policy, found here.



Attire

During the day, students should wear school-appropriate attire that is casual but still looks nice. (Long pants, skirt, jeans without rips, nice t-shirt, blouse, etc.). If they have a t-shirt from their school/organization Chorus program, they are welcome to wear that. Upon arrival, each student will receive a t-shirt. For the concert, please wear this **honor choir t-shirt and solid black bottoms** that go at least to the knees. There are no specific shoe requirements.

FROST HONOR CHOIR AT THE UNIVERSITY OF MIAMI

CONSENT, WAIVER AND RELEASE AGREEMENT PLEASE READ CAREFULLY

IN CONSIDERATION for being permitted to participate in the FROST HONOR CHOIR event (th
"FROST HONOR CHOIR"), being held in the Gusman Concert Hall 1314 Miller Dr, Cora
Gables, FL 33146 at the University of Miami on October 24, 2025. I,
, hereby agree as follows:

- 1. I acknowledge and expressly consent to my participation in the **FROST HONOR CHOIR** event being held at the Gusman Concert at the University of Miami on October 24, 2025.
- 2. I acknowledge that my child's participation and presence at the **FROST HONOR CHOIR** may expose him/her to risks and dangers, some being inherent in the nature of the activity, some resulting from human error and negligence on his/her part and/or on the part of other personnel working or participating in the activity. I acknowledge that any of the above-referenced risks and dangers may cause damage or loss of personal property, personal injury and even death, and I fully assume and accept these risks and dangers.
- 3. I understand that my child's participation in **FROST HONOR CHOIR** activities is entirely voluntary on the part of my child and agree that it is my child's responsibility to (1) act within the limits of his or her ability; (2) heed all warnings about participating in any activity; (3) control his/her person, equipment and devices used to participate in an activity; and (4) not act in any way that may cause injury/death or contribute to the injury/death of others or of himself/herself while participating in any activity.
- 4. I hereby agree to assume and take on behalf of my child, his/her family, heirs and personal representative(s), all of the risks and responsibilities in any way associated with my child's participation in the **FROST HONOR CHOIR**. I hereby agree to release, waive, indemnify and hold harmless the University of Miami, its officers, directors, trustees, employees, faculty, students, volunteers, agents and representatives (collectively, referred to as the "<u>University</u>") from any and all claims, demands, damages, causes of action, suits, whether in law or in equity or however caused, against, including without limitation, any damage to or loss of personal property, any personal injury and/or death, which my child or I may have or may acquire as a result of his/her presence and participation in the **FROST HONOR CHOIR**, including, without limitation, damage, loss, injury and/or death caused by the negligence, in whole or in part, of me, my child, the University or any third party.
- 5. I understand and agree that this Consent, Waiver and Release Agreement applies whether the University of Miami is at fault or not.
- 6. I understand and agree that the University of Miami may not have medical personnel available at the location of the <u>FROST HONOR CHOIR</u>. I hereby grant permission to the University of Miami to authorize emergency medical treatment, if necessary, and agree that such action by the University of Miami shall be subject to the terms of this Consent, Waiver and Release Agreement.





I understand and agree that the University of Miami assumes not responsibility for any injury or damage which might arise out of connection with such authorized emergency medical treatment.

- 7. I understand that in securing the execution of this Consent, Waiver and Release Agreement, the University of Miami is acting as agent or trustee on behalf of or for the benefit of its respective employees, agents, officials, faculty, students, servants and representatives, whether paid or unpaid, who shall to this extent be, or be deemed to be, parties to this Agreement.
- 8. This Consent, Waiver and Release Agreement shall serve to benefit and bind the University of Miami and myself and our respective heirs, executors, administrators, successors and assigns.
- 9. This Consent, Waiver and Release Agreement shall be governed and construed in accordance with the laws of the State of Florida, and any dispute arising from or relating to this Agreement shall be brought exclusively in a court of competent jurisdiction located in Miami-Dade County.
- 10. I certify that I have read the terms of this Consent, Waiver and Release Agreement and understand its contents, and that I wish to be bound by its terms.

I UNDERSTAND THAT THERE ARE RISKS OF INJURY INVOLVED IN MY CHILD'S PARTICIPATION IN THE <u>FROST HONOR CHOIR</u> AND MY CHILD AND I VOLUNTARILY ASSUME SUCH RISK. IT IS MY INTENTION BY SIGNING THIS CONSENT, WAIVER AND RELEASE AGREEMENT TO EXEMPT AND RELIEVE THE UNIVERSITY OF MIAMI FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH CAUSED BY MY NEGLIGENCE, MY CHILD'S NEGLIGENCE, OR THE NEGLIGENCE OF ANY OTHER PERSON(S) PARTICIPATING IN, OR AFFILIATED WITH, THE <u>FROST HONOR CHOIR</u>.
